



**INAUGURAL MEDICAID SCHOOL PROGRAM STAKEHOLDERS MEETING
MEETING REPORT**

Wednesday, October 26, 2016

Introduction

Mike Collins, State Board of Education Member (SBOE), and OSHSA Team Leader provided an overview of OSHSA and it's activity going forward in 2017. He reviewed information about the following subjects:

- Re-branding of OAME (to OSHSA)
- MSP Stakeholder Meetings
- Program Training
- Relationships with State Agencies
- Billing Vendor Collaboration

During Mike's twenty minutes of comments he highlighted the reasoning for the rebranding of OAME, the importance of Stakeholders Meetings, the implementation of training programs, the relationship of the Stakeholders to State Education Associations and related State Government Agencies. Finally he spoke to the balance of importance of each Billing Agency and Accounting Partner and the strength of each equal entity.

MSP Update

Dan Thomas, owner of HBS and Team Leader of OSHSA, provided a thorough overview of the MSP issues and activities being addressed by all the Stakeholders in the room. Highlighting his remarks were his perspectives on:

- ORP Update
- Coordination of Care
- MAC
- Claim Processing Manual
- Deadline/Final Settlements
- 2014/15 Cost Report
- Free Care
- Aide Services
- Therapist Enrollment

The significant points of Dan's comments under each category are spelled out in Attachment #1; attached to this report. There were periodic questions and clear responses throughout his 45 minute presentation.

AUP Update – Ken Richards

Ken Richards, Partner of KCR and OSHSA Resource Partner, took the attending group of twenty six through the AUP Update and his specific comments on:

- 2014/15 AUP Engagement letter changes
- Final due date for 2015/14 Cost Report/AUP

Legislative Update – Bryan Williams

Bryan Williams, Registered Lobbyist and OSHSA Team Leader, reviewed the history and current status of SUB. HB 89. He particularly noted the ORP ODM Agreement with the content of the revised HB 89. The major components of his presentation are as follows:

Next Steps

Mike Collins talked about the future engagement and ultimate Board Leadership component of School District Personnel as OSHSA moves forward as the professional organization for the MSP Family. He asked for the Stakeholder attendees to recommend school district personnel from their respective clients to assist in the formation of the OSHSA Board. He is looking forward to receiving these recommendations before November 11.

Dan outlined the training opportunity on Cost Reporting, AUP for billing agencies and related CPA Firms to be held prior to Thanksgiving. Additional information on this opportunity will be coming the First Week on November. Dan also discussed future MSP Stakeholders Meetings, with the next meeting anticipated to be held in January. Again, more information will be forthcoming.

Bryan reviewed the adoption process of SUB. HB 89 and requested attendees to assist in generating support letters from districts in the Senate Committee's respective districts. A suggested format for such a support letter and a listing of the districts represented on the Senatorial Education Committee are attached and identified as Attachment # 4.
